ORDER:-

The Hon'ble Minister (Municipal Administration, Rural Development and Implementation of Special Programme) has announced in the floor of Assembly while moving the demand of Rural Development and Panchayat Raj Department (Demand No.42) on 21.06.2017 that the Additional Charge Allowance of Rs.500/- per month will be paid to Panchayat Secretaries, holding Additional Charge of the post of Panchayat Secretary, which are kept vacant.

2) In the letter read above, the Director of Rural Development and Panchayat Raj has sent a proposal and requested the Government to sanction Additional Charge Allowance of Rs.500/- per month for the concerned Village Panchayat Secretaries, holding Additional Charge of the post of Village Panchayat Secretary in the vacant Village Panchayats through Account No.VII, for which fund is being apportioned from SFC grant.

3) The Government, after careful examination of the proposal of Director of Rural Development and Panchayat Raj, accord to sanction Additional Charge Allowance of Rs.500/- per month for the concerned Village Panchayat Secretaries holding additional charge of the post of Village Panchayat Secretary, in the vacant Village Panchayats through the Account No.VII of the respective Village Panchayats, which will be met from the SFC grant.
