Sub: Group Insurance Scheme - Employees working in Village Panchayat - Revision of Management contribution of Local Bodies and Village Panchayat - Orders Issued - Intimation - Instruction - Regarding.

I invite kind attention to the letter 4th cited, in which, The Commissioner of Treasuries and Accounts, Chennai has stated that, the Government vide G.O 1st cited, has enhanced the lump-sum payment of Group Insurance Scheme for the employees of Local Bodies and Village Panchayats from Rs.3,00,000/- to Rs.5,00,000/- and also ordered to deduct an amount of Rs.110/- as employees Subscription per month per employee with effect from 01.09.2021 and remit it into Government Account.

Further, it has been stated that vide G.O. 2nd cited, the Management contribution under Group Insurance Scheme has been enhanced from Rs.165 to Rs.265/- to Local Bodies and Village Panchayats covered under Group Insurance Scheme with effect from 01.09.2021.

Further, The Commissioner of Treasuries and Accounts, Chennai has informed that, the Panchayat Union Namagiripettai, Alangulam, Kadayam, Kadayanallur, Keelapavoor, Kurivikulam, M.N.Nallur, Sankarankoil, Shencottai, Tenkasi, Vasudevanallur, Mallasamudram, Senthamangalam, Vennadhur has remitted only Rs.165/- instead of Rs.265/- for the month of January / February 2022.

Hence, it is hereby requested to give necessary instruction to all BDOs and Village Panchayats to remit the enhanced management contribution Rs.265/- and the employees contribution of Rs.110/- (totaling Rs.375/- per employee per month) with effect from 01.09.2021 as per the Government Orders into the Government Account along with the arrears if any.

Further, All District Collectors are requested to inform, the details of remittance of enhanced Management contribution as per Government order to, The Commissioner of Treasuries and Accounts, Chennai on or before 15th of every succeeding month to The Commissioner of Treasuries and Accounts, Chennai.

It is also requested to Acknowledge the receipt of the letter to this Directorate immediately.
